## IT PROVIDES THE SPECIFIC FEATURES OF THE CRIMES INVOLVING FEMALE-GIRLS AND THE POSSIBILITY OF THEIR USE

#### **ANNOTATION:**

In recent years, a completely new system and reforms have been implemented in our country to strengthen the role and status of women in society, ensure their rights and freedoms, increase their socio-political activity, medical culture and intellectual potential, especially strengthening families. First of all, a new system has been created to improve the socio-spiritual environment in families and coordinate the activities of public organizations in this regard. In this article, we consider our proposals and recommendations to address this problem in the country today, based on the socioeconomic potential of the regions, demographic composition, employment, prevention of crimes involving women, the causes and other factors. we tried to find analytical solutions by summarizing the results of our research.

### **INTRODUCTION:**

The family is the most basic and primary unit of society since its inception. In the language of the law, "The family is the basic unit of society" [1]. In it, the sacred word MOTHER is a symbol of a grateful teacher, who has a great power to give birth to and nurture the founders of the family and society, to regulate society, to inculcate social moral norms in people's minds.

It is a pity that in our society today, some unclean women, who tarnish this sacred name and tarnish its image, modesty and beautiful image, are often found among people. The commission of so many crimes by women, including theft, hooliganism, murder, killing one's own baby, fraud, complicity, prostitution, is causing new problems for our society along with a great disaster in the very future.

If we look at the historical facts, the types of crimes involving women, their causes, and measures to prevent them were first considered by European sociologists in the 60s and 70s of the XIX century. Examples include scientists such as Lambert Adolf, Jacques Kettle and Cesare Lombroso. In our country, the criminological characteristics of women's crime during the years of independence, the issues of their prevention have been studied by scientists of our country ZS Zaripov, KR Abdurasulova, I. Ismailov, YM Karaketov, M. Usmonaliev.

Studies have shown that physical weakness, women's ability to adapt quickly and easily to changes in life, and their ability to easily get out of difficult situations create unusual opportunities to hide crimes. This, in turn, increases the tendency to commit crimes over the long term.

Russian scientist, academician Kudryavtsev, states that crimes committed by women differ from crimes committed by men by:

1. Criminal nature;

- 2. Methods of execution;
- 3. Tools;
- 4. Consequences of the crime;
- 5. Selection of the victim.

In addition, it is more common for men to commit crimes committed by women out of strong excitement and carelessness. At the same time, in practice, women who have committed the crime of theft or fraud are more likely to commit the crime on their own. However, the amount of damage caused by the theft or fraud committed under the plan is not very large [2]. In addition, crimes committed by women also differ in the motive of the crime. They are the first. in turn jealousy, revenge, jealousy, manifested in their attempts to get rid of the victim. Many crimes committed by women are the result of the victim's illegal behavior.

When examining crimes committed by women, it is also clear that they are not married or divorced, and that the role of men as the head of the family in the family environment is not as strong as that of the father or husband. Crimes committed by force, such as murder, robbery, aggression, and hooliganism, are often committed by men.

Our President Sh.M. Mirziyoyev: "Crime

among women is an increase in family divorces." [3] It is a bitter and unpleasant issue that is not unique to our people, such as the exposure of young people to various religious extremist movements and terrorist organizations.

In recent years, women have also been involved in crime. It is characterized by a lack of human qualities, in other words, a serious defect in spiritual maturity. Thefts and hooliganism by women are most common in urban areas or public places: shops, shopping malls, restaurants, and corridors where people are congested. Women who commit the crime of theft are mainly uncles, gypsies and homeless people. In the last five years, the number of unmarried or divorced women in this category has increased. This is due to the high level of influence of various emotional states that occur in the human psyche. That is, there are various "survival" challenges that this category of women face throughout their lives.

In crimes involving violence, women make up a relatively small percentage of men. Interestingly, however, it is observed that crimes of violence committed by women are brutal and that their behavior is mainly directed at the spouse and the spouse, as well as in some cases the close relatives of the spouse, especially the mother-in-law. In our opinion, this is due to the changing social role of women in life, the deterioration of the family environment and the lack of confidence of women in spiritual life.

Another type of crime committed by women is for women to kill their own baby. This crime is mainly committed by young women or women who are still unmarried and pregnant. This is due to the fact that young people are still deceived by the lack of understanding of certain issues and the lack of conditions for shaving a child, and the shame in girls is the strength of aria. It is also done in order to preserve the honor and dignity of his parents and himself in front of the neighbors. Crimes such as conspiracy and prostitution (Article 130) of the Criminal Code of the Republic of Uzbekistan also constitute the majority of crimes committed by women. The reasons for this are also different, with some criminals claiming to be in financial trouble, while others claim that they are simply "enjoying lust." But in our opinion, we believe that the root of both causes is the effect of spiritual-moral degradation.

In recent times, we can see that crimes among women are also more related to crimes related to drug trafficking and possession. The reasons for the increase in the number of such crimes every year are the following general conclusions:

First, the difficulties in life that we face in human life today, the despair, insecurity, indecision, and unwillingness of women towards the trials of life;

Second, the reason why women commit crimes related to theft and fraud is that the processes of raising and raising children in the course of life and marriage are mainly the responsibility of women, who remain the sole "supplier" in the family;

Third, the disruption of the social environment in the family, the aggravation of the relationship between spouses and children, the lack of a full understanding of the responsibilities of men as the head of the family;

Fourth, the desire to live an easy life, that is, the desire to find oneself in life in the "formula of a happy life";

Fifth, drugs that poison the human mind, weaken the mind, are factors such as moral depravity as a result of the addiction to alcohol consumption.

It should be noted that inequality in society, instability in the psyche of the individual, violation of national values, deterioration of living conditions and family environment, moral lameness, incompetence of the head of the family are common factors in society, increasing women's crime. Results and recommendations of the analysis of crime among women.

Crime among women today has its own characteristics, based on its social characteristics. These features are directly related to the historical, geopolitical, economiclegal, demographic and other changes taking place in society. These changes are especially evident in the micro-social environment of women's life [4].

The microsocial environment has different negative effects on different stages of a woman's life path. This is determined by certain socio-demographic differences, including age, employment, financial status, status of family relationships.

In practice, we are all concerned that the proportion of crimes committed by women in the family has also increased significantly. Of particular concern is the commission of serious and very serious crimes under the Criminal Code of the Republic of Uzbekistan. Examples include torture (CK-110 m), premeditated murder (CK-97 m), bodily harm (CK-104,105,106-m), and intentional killing of a mother's own baby (CK-99-m).

In the Criminal Code of the Republic of Uzbekistan, the intentional killing of a mother by her own child (CK-99-m) differs from other types of murder by its specificity and the nature of the crime.

The crime of intentional killing of a mother by her own child is committed as a result of a woman's special mental and physical condition during childbirth or immediately after birth. The crime is related to the birth of an unwanted fetus and to the mental process that results from being raped or cheated on by promising to marry. This situation is less common in the criminology of Western European countries. We believe that this is due to the fact that women have a good mastery of medical, psychological and legal literacy, high living conditions, a well-organized system of social protection for women.

There are very few married women among women who have killed their newborns. Most of them are nomadic women, usually with low skills and education. A murdered child is often associated with the first unsuccessful sexual experience. Many of them are parents, and it is precisely the fear of negative parental attitudes that drives them to kill their babies [4].

We have developed a number of new recommendations based on the findings and analysis of the study of crimes against women in Andijan region.

The analysis identified 482 cases among women in the region in 2018, 397 in 2019 and 437 in 2020. Most of the women who committed crimes were involved in fraud, theft, economic crimes, and drug-related crimes. Including,

- Fraud was detected in 57 cases in 2018, 89 cases in 2019 and 99 cases in 2020;

- Crimes among women related to theft in 32 cases in 2018, 41 cases in 2019, 23 cases in 20120;

- Crimes in the economic sphere in 61 cases in 2018, 67 cases in 2019, 98 cases in 2020;

drug-related crimes were reported in 46 cases in 2018, 31 in 2019, and 39 in 2020.

When we analyze these crimes, the areas with the highest crime rates are the most densely populated areas. For example, in the city of Andijan, Andijan district, Asaka district, Shahrihan district, Kurgantepa and Markhamat districts, crimes involving women were more common than in other regions. When we look at the crime rate among women in January-February 2021, which is exactly the same as in January and February of previous years, it can be seen that crime increased by 53.8%. These crimes also occur in densely populated areas.

It should also be noted that women who commit crimes of fraud and theft live in rural areas, but the crime scene is most often in district and city centers or in the regional center, particularly in Andijan. The analysis also revealed that the majority of individuals who commit fraud and economic crimes are officials or their relatives. Examples are MFY employees, employees of education, medical institutions, bank employees.

When asked what caused these individuals to commit the crime during the investigation and inquiry, they said that they "needed money" or "did not know the legal consequences". However, when examining their marital status and literacy level, it becomes clear that the above reasons are simply an "excuse" to escape punishment. Based on the above, the Andijan Regional Department of Internal Affairs has developed the necessary action plan.

This action plan specifies the following:

1. Crimes committed by women during 2020 to study and provide practical assistance in the organization of effective work with public organizations in the fight against delinquency and crime among women in all cities and districts (Andijan, Andijan, Asaka, Boston, Balikchi, Ulugnor, Kurgantepa districts);

2. Based on the analysis of 2020, systematic work on the prevention of fraud and theft by women, employment of women, systematic work in collaboration with the Department of Employment by senior inspectors on women's issues in the city IIOFMB and all city-district IIB sending and supervising the organization;

3. In order to protect women from oppression and violence, to conduct regular surveys of families in the mahallas, in cooperation with the competent authorities and organizations engaged in this activity, to conduct advocacy activities on the topic "Do not become a victim of violence." participation in preventive measures with perpetrators of violence and reporting on protection orders issued by territorial prevention (senior) inspectors to women who are victims of violence and oppression;

4. In accordance with the instructions of the

President of the Republic of Uzbekistan on October 8, 2020 at a video conference on measures to increase the role of women and youth in society and ensure employment, "Youth Book" and "Women's Book" were formed. take measures to eliminate problems in cooperation with relevant agencies;

5. In order to ensure the implementation of the Decrees of the President of the Republic of Uzbekistan dated February 18, 2020 PF-5938 and 30.10.2020 PF-6099, women in need of assistance and in difficult social situations, including women with disabilities, regular participation in social, legal, psychological and financial assistance, promotion of healthy lifestyles among women;

6. To study the preventive measures carried out by women who are on the preventive account of law enforcement agencies (previously convicted, have committed a crime, are on probation, prone to crime), in this regard, government agencies and civil society on their healthy lifestyles organization of preventive work in cooperation with institutes, attachment of educators-coaches from their places of residence;

7. Compile lists of women registered in health departments (alcohol, drug addicts) and conduct targeted preventive work with them.

8. Active participation in monthly events on the action plan to organize actions under the slogan "We are against violence" in the regions on the occasion of the International Day for the Elimination of Violence against Women, announced by the UN General Assembly on November 25;

9. Implement targeted preventive measures for the social rehabilitation and social adaptation of women released from penitentiary institutions, previously convicted, victims of oppression and violence, their return to a healthy lifestyle, ensuring their employment;

10. Organize the provision of material and moral support to women in difficult social situations, living in low-income families, as well as caring for children with disabilities or disabled children through community members, women's committees and sector leaders;

11. To identify women in difficult social situations in order to prevent suicides and suicides, to carry out systematic measures with them with the help of psychologists, to investigate the causes of suicide and to issue protection orders against harassment;

12. Meetings with women on women's issues, in cooperation with other public organizations in cities and districts, and solving their problems.

### **CONCLUSION:**

It is a positive thing that women and girls are active in society, understand their important role in governing the state and society, advance in the social arena, and try to show what they are capable of. But it is natural that the use of any immorality, illegal actions and means to achieve this goal will seriously damage our development.

Therefore, preventing the increase in crimes involving women is the most important task of law enforcement officers, in particular, prevention inspectors, public safety officers, local authorities, educational and medical institutions.
