In order to identify current social problems, periodically study public opinion, based on which programs and guidelines for elimination of conflict situations, domestic violence and suicidal behavior are developed and implemented. analysis and generalization of conflict situations, domestic violence and suicidal behavior, their causes and conditions, dissemination of information and analytical materials, including in the media and on the Internet. ensured that the public is informed about the problems. Practices, seminars and trainings on conflict situations, domestic violence and suicidal behavior are conducted for employees of public authorities and
