4 decisions of the President of the Republic of Uzbekistan, 6 decisions of our Government, 4 orders and 12 programs of measures were adopted, and the legal basis for increasing the socio-political activity of women in the modernizing Uzbekistan and their equal work in all spheres was created. Today, the institutional framework for gender equality is expanding in our country. Meanwhile, within the Senate of the Oliy Majlis of the Republic of Uzbekistan, a new Women's and Gender Equality Committee was established, which is engaged in harmonizing international standards in the national legislation on ensuring women's rights and eliminating any form of discrimination.

As proof of this, the head of our state in his address to the Oliy Majlis entrusted the committee with the task of providing women's employment, especially 13,000 women who have fallen into a difficult social situation with jobs and 1,600 women with homes, and the committee has defined specific plans in this regard. , it is true that practical work is being carried out.

Every year, 1,600 women are given practical help to form the initial contributions of the housing sum from the funds of the fund.

Necessary measures are being taken to provide financial assistance to women with disabilities from the funds allocated for the public fund for women and family support, and to provide them with means of rehabilitation.

CONCLUSION

In conclusion, it is necessary to convey and promote to the general public the essence of the reforms implemented in our country regarding the support and development of the state policy regarding women. Therefore, in order to further strengthen the role of women who are politically active, with mature spirituality, and are an important pillar of society, the following is suggested: first, in order to strengthen the participation of our women in state and society management, it is necessary to convey

the programs of political parties to the general public. Secondly, it is necessary to convey programs in mass media that increase political and legal knowledge in popular language.

Thirdly, special attention should be paid to increasing the legal literacy of women in the family. In order not to become a victim of family violence, it is the need of the time for our girls to be morally high along with their rights.
