Introduction

Even in the holy books, there are many definitions about maintaining a family and bringing up children. Nowadays, family morals and ethics, family conflicts and the resulting breakdown of families are widely studied as problems.

In our country, in the process of preparing sons and daughters for marriage, parents do not properly explain the responsibility of marriage, the responsibility of husband and wife for the family, the duties and responsibilities of raising children, the results of early marriage of young people, the ignorance of young people in maintaining a family. , it is possible to meet young people who are unable to maintain

their families as a result of not having the necessary skills in livelihood and interference of fathers and mothers in the lifestyle of young families. Although 184 thousand 461 marriages were registered in the demographic data of Uzbekistan for the 9th month of 2023, the number of divorces is 37 thousand 654. Behind these pitiful figures, there is a young generation that is deprived of parental love, lacks a sacred place called family, which affects the future of tomorrow, and has to grow up in an environment with spiritual and material deficiencies, which worries our society.

It seems that every parent should properly explain the responsibilities of marriage and family, the rights, duties, and responsibilities of married couples while preparing their children for marriage. Only then, a healthy family will be built in the society under the leadership of parents who are responsible for the children, who are the foundation of tomorrow's future.

We can say the following factors and conflicts in the family that can cause young families to divorce.

Of these:

- young bride and groom relationship;
- environment in the family where the new bride comes from;
- relations between father-in-law and mother-in-law;
- the child's attitude towards his parents;
- the groom's attitude towards the bride's parents;
- relations between mother-in-law and daughter-in-law;
- relations between gods;
- relations between relatives living in the same family.

It is natural that conflicts in young families are caused by conflicting relationships and disagreements between individuals. From a psychological point of view, divorces occur in young families as a result of these conflicts.

If we focus on the definition of conflicts of origin in young families given by scientists, a conflict is a problem, issue or problem in the mind of some individual, or in the process of interpersonal communication, within a group or at the time of intergroup interaction and influence. It is a socio-psychological phenomenon that indicates a relationship full of negative emotions, which is a result of conflicting opinions, views and positions that do not correspond to each other.

Boys and girls who grow up in a healthy environment in the family consider the parent-parent relationship in their family to be ideal, and in their future families, boys will be like their father, and girls like their mother, "father", "mother", "husband", " they dream of becoming a wife.

One of the most characteristic of young family conflicts is the conflict between husband and wife. Under the difficulties that arise after marriage, they are mistaken in choosing a spouse because their marriage is not what they dreamed of, and as a result, they find fault with trivial things and do not listen to each other.

In young families, conflicts in the family increase as a result of husband and wife not understanding and listening to each other. On the contrary, conflicts and problems that may arise can be solved only by hearing and listening to each other. At this point, it is enough to recall the experience of communication masters such as Dale Carnegie.

As a result of the disputes that arise in young families, there are cases of family divorce due to

domestic and mental violence and regular torture caused by the husband's consumption of alcohol products.

The basis of divorces can often be found in the periodicity of developing families, that is, from the time of marriage to 10 years. During this period, factors such as material shortages in the family, failure of the head of the family to regularly provide for the family, lack of household skills not taught by the mother in the house of the housewife, betrayal, excessive jealousy, and illness that occur in some cases may be the cause.

Most of the brides who have just joined the family overcome the problems that arise and fulfill their duties as brides perfectly. In the process of adapting to the new family, with the help of the mother-in-law, the brides become real members of this family. Mothers-in-law are advisers to daughters-in-law, and daughters-in-law are assistants to mothers-in-law. At the same time, disagreements between mother-in-law and daughter-in-law are common in our society. The reason for this is the world view of the two generations, the mismatch of life principles, the finding of fault in the work of the brides, in some cases the mother-in-law is angry with her children, the shortcomings of the daughters-in-law in making a living, the daughter-in-laws do not talk about themselves. resulting from the strong effects on transfer. In such cases, mother-in-law's support of brides plays a key role in forming practical skills that they will need for the future of their children and future grandchildren. In some cases, factors formed in the minds of young people before marriage also affect them. Some girls have formed negative impressions about their mother-in-law before marriage. In the new family, he begins to look for the negative image of the mother-in-law, flaws in the mother-in-law. Even their spouses forget their family membership and begin to abuse their mother-in-law. There are brides-to-be, who tend to confuse the idea between the mother-in-law and the daughter-in-law. Under the influence of these factors, conflicts begin to arise in young families. It is the saddest situation when a family gets divorced as a result and end of family disputes.

Conflicts in the family and their consequences can affect the development of our future generations as mature children, as well as make them grow up without parental love, create material and spiritual gaps, and form individuals who cannot find their place in society. . When studying the family situation of young people who commit crimes, it is proven that most of them have grown up parents. We can see that the above-mentioned factors lead to the divorce of young families, and the lack of spiritual maturity in the marriage of young people.
